








JDPs evolution (2013-2018)





Regional cooperation



- EFCA has continued cooperation during 2018 with the Control Expert Groups (CEGs) of four regional bodies (Scheveningen, BALTFISH, NWW and SWW) created by Member States and active in the framework of the CFP regionalisation.
- The main areas of cooperation for which these groups have requested EFCA assistance are:
 - Developing risk assessment on the implementation of the LO
 - Assisting on the cooperation with industry
 - Promoting and supporting standardisation
 - Performing a compliance evaluation with the LO



Pilot project for control of turbot in the Black Sea 2018



- Pilot Project under Para's 52 and 53 of GFCM/41/2017/4 to adopt before the end of 2019, a voluntary observation and inspection programme
- Cooperation agreed between EU and Georgia, Turkey, Ukraine
- Joint inspection and control activities:
 - Regional controls and inspections: Lundy Sentinel + Osprey deployed April with MS+TC inspectors: 19 inspections + 84 sightings
 - New control technologies: Use of Copernicus imagery
- Exchange of best practice and common implementation of GFCM control rules
- Inspector training and capacity building in Ukraine, Georgia and Turkey







Strait of Sicily cooperation during 2018



Support to the implementation of IUU Regulation



- EFCA provide support to the Commission for evaluation mission to third countries as regards IUU fishing Regulation.
- EFCA assisted the European Commission with the analysis of a total of 435 catch certificates and 195 processing statements (Annex IV of Regulation (EC) 1005/2008) for 7 third countries
- EFCA organised training for EU officials and cooperate with Third Countries on request of the Commission




Annual coast guard event

In 2018, EFCA hosted the first Annual European Coast Guard event organised in the framework of the Tripartite Working Arrangement (TWA) as the first Chair of the TWA Steering Committee.

The event got together the communities of the three agencies on 11 and 12 April in Isla de la Toja, Pontevedra, Spain.

The aim was to serve as the main forum for discussions, to provide feedback and to identify possible activities for the future cooperation of the Agencies in support to national authorities carrying out coast guard functions.


